## OUR HONORED GUEST: MERRY ANN T. WRIGHT, PRESIDENT GENERAL, NSDAR



President General Merry Ann T. Wright has been a DAR member for 46 years and has a distinguished service and professional background. She was elected to the position of President General after serving the National Society at every level. This includes being one of the first Presidents General to have also served

on the NSDAR professional staff. This experience has given her a unique understanding and expertise of the management of this multi-faceted membership organization.

As President General, Mrs. Wright heads the 122 year old women's volunteer service organization which includes over 170,000 members in nearly 3,000 chapters in the United States and 13 foreign countries. As Chief Executive Officer of the non-profit organization, she also leads a professional staff of 140 at the National Headquarters in the heart of Washington, D.C. The staff is responsible for the day-to-day operations of the Society as well as the maintenance and promotion of the Society's National Historic Landmark buildings, which are open to the public.

The theme of this administration, 'Preserve the Past, Enhance the Present and Invest in the Future,' will determine how we will work together," explained President General Wright in her installation speech. "It will reflect our decision-making about each program and activity and how to carry out our mission to promote historic preservation, education and patriotism."

This theme and the energy of President General Wright have brought growing numbers of members to the Society, surpassing the 900,000 mark for the 122 years of the organization. Through her drive, NSDAR has provided thousands of dollars in grants to over 90 non-profits; increased chapter involvement in historic preservation, education, and patriotic endeavors; and has overseen restoration and repairs of its headquarters buildings in Washington, DC. Mrs. Wright was the first NSDAR Director of Development, being recruited by the organization to launch its first development department in 1998. She served in that position for nine years, building the foundation of successful funding initiatives that thrive today. Prior to that, she served as the Chief Executive Officer and President of the American Lung Association of Mid-New York in ten upstate New York counties for 13 years, after serving for three years as their Development and Public Relations Director.

Mrs. Wright retired as the NSDAR Director of Development in order to serve as NSDAR First Vice President General, from 2007-2010. Her additional extensive national leadership service in the Daughters of the American Revolution include 15 years on the National Board of Management (the governing board of the Society), eight different national chairmanships, and four other national vice chairmanships.

These varied executive experiences gave Mrs. Wright liaison responsibilities and oversight over such key committees of the Society as Public Relations and Media; Continental Congress; Development; Long Range Planning; Personnel; Investment; Finance; and Special Projects and Events. She also spent six years on the Technology Advisory Committee, which was a driving force behind the digitization of millions of the National Society's genealogical records.

She has distinguished service in New York State, including serving as State Regent of New York, as well as many other state offices and chairmanships. She was twice honored as the DAR New York Outstanding Junior and was named one of eight division finalists for National Outstanding Junior of the year.

In addition to Mrs. Wright's extensive DAR service, she is also very active in her church and community, including serving on boards of local charities and being a past member of the Rotary Club and Association of Fund Raising Professionals.

Mrs. Wright grew up near Syracuse, New York, and now resides in Leland, North Carolina with her husband Lawrence F. Wright. She is the mother of two sons and two stepsons, and grandmother of five.

#### Mary Agnes McAlleenan, Wyoming State Regent



Mary Agnes McAleenan has been a member of NSDAR since 1984. She has served her Fremont Chapter as Regent, and has served the Wyoming State Society as Recording Secretary and Organizing Secretary. She was elected State Regent in 2012. She worked overseas for the U.S. Department of State for a number of years, and is glad to be back in Wyoming, enjoying farming and ranching.

Robert C. Oaks



Robert C. Oaks was born in Los Angeles, California. He grew up in Provo, Utah, where he graduated from Brigham Young High School, then entered the first class of the U.S. Air Force Academy after attending Brigham Young University for one year. He graduated from the Air Force Academy in 1959. In 1967 he received an MBA degree in personnel management from The Ohio State University. He also attended the U.S. Naval War College in 1973-74.

Upon graduation from the Academy, he completed flight training and fighter gunnery training, and later flew combat missions in Vietnam. Over the course of his thirty-five year career, he was able to keep returning to fighter operations, and was flying F-16 Falcons in Germany at the time of his retirement in 1994. He commanded units at all levels of the Air Force. At Ramstein Air Force Base in Germany, he commanded the 86th tactical fighter wing and later was commander of U.S. Air Forces Europe. He also commanded allied NATO air forces in Naples, Italy and at Ramstein, Germany. He retired as a General from the United States Air Force after more than 35 years of service. Following his retirement he moved to Pittsburgh where he became the senior vice president for operations at US Airways.

Gen. Oaks was awarded the Distinguished Flying Cross for his Vietnam service, and two Distinguished Service medals. He is also the recipient of the Brigham Young University Alumni Achievement Award and the United States Air Force Academy Alumni Association Distinguished Graduate Award.

In April, 2000 he was called to serve in the Second Quorum of the Seventy as a General Authority for the Church of Jesus Christ of Latter-day Saints; he was released as a General Authority in October, 2009, and returned to his home in Utah.

#### Cindy McCoid Toone, Vice President General, Honorary State Regent of Utah

Cindy McCoid Toone has been a member of the NSDAR for 22 years, when she joined as a junior member at the encouragement of her mother. She has served at the chapter level of both the Salt Lake Valley Chapter and the Sego Lily Chapter, as regent as well as other offices and chairmanships.

Cindy was elected Vice President General, NSDAR at Continental Congress in 2012. She will tell you it is a

privilege and a pleasure to continue to serve the NSDAR as a one of seven members of the Class of 2015. Cindy served as 60th Utah State Regent. During her term in office, she encouraged Utah Daughters to "Get Involved" by planting trees to commemorate past Utah State Regents. She has also served the Utah State Society as Vice Regent, Organizing Secretary, and Corresponding Secretary as well as committee chairman of DAR Schools, Flag of the United States of America, Junior Membership, and Children of the American Revolution. She served as Southwest Division Vice Chairman C.A.R. She was a Utah State Outstanding Junior. She served as a Continental Congress page for 5 years, and has served on various house committees.



Cindy has served as Senior National Vice President of the Rocky Mountain Region, Senior State President, and Senior Society President of the Dominguez y Escalante Society for Children of the American Revolution.

She has been married to her husband, Alan Toone, for 35 years. They have 3 children: a son living in California who was recently married, a daughter who

graduated from the University of Utah in Civil Engineering, and a daughter working at Zion National Park with her husband, who just introduced Cindy to the joys of being a grandparent.

Cindy works full time for JC Penney at their accounting center in Salt Lake City, but is NOT an accountant. Cindy and her husband are renovating a historic home built in 1891, and hope to move in sometime before it kills them. Between DAR, work, and the house that might not be far off!

#### From the Chapters

#### Bear River - Joanne Jensen, Regent

The Bear River Chapter has been busy with activities for soldiers and veterans this year. We mailed seven packages to soldiers last fall, and made 5 pillowcases for veterans. On Sunday evening, November 11th, an Honorary Veteran's Celebration was held at the Beehive Retirement Home with a patriotic program, refreshments and music. Two veterans were honored and given patriotic pillowcases. Marilynne Wright was chairwoman of this successful event. Ruth Lehenbauer provided the music, and Lucy Johnson sang a solo. At our Christmas party more items were donated for boxes for soldiers; we presently have three more boxes ready to mail. Fortunately, the soldiers who previously received boxes have returned from Afghanistan, so we are in the process of getting additional soldier addresses. We recently finished folding pocket flags to hand out to soldiers leaving on a tour of duty.

We've had two recent genealogy programs. In October, Clive Romney gave a wonderful program entitled "Genealogy through Music and the Arts". He encouraged us to research information about our great-grandparents, grandparents, etc. so that we could really "know" them. He performed, with the help of a guitar, many of the poems and songs he had written in remembrance of his ancestors. In January

our Anniversary Luncheon was held with the theme "Sharing Genealogy Successes". Members presented two-minute talks about a particular ancestor, or a current genealogy success.

In November, Bear River Chapter recognized the 50<sup>th</sup> anniversary of the Cuban missile crisis. Eric Swedin was the speaker, and reviewed the events of that time. Then he gave a presentation of his awardwinning book, "When Angels Wept, An Alternate History of the Cuban Missile Crises".

#### Color Country - Alta Thorpe, Regent

Greetings from Color Country Chapter (CCC)! We continue our commitment and service to DAR and to our community, with focus on Service to Veterans. Thanks to the generosity of CCC members, we have exceeded our goal of 108 lap robes for the new 108-room veterans' home under construction in Ivins, Utah. Additionally, CCC helped to support a new veteran's mental health center. The target population of the new center is veterans who served in Iraq and Afghanistan, and their families. Through the generosity of the Catholic Thrift Store, we provided 25 books and 12 toys to the center. CCC provided five dozen cookies for their Christmas Party.

We take cookies to the local veterans' outpatient clinic as well as holiday cards with handwritten messages of appreciation for their service to our country. American flags are presented to veterans in local nursing homes. CCC has also provided individual gift bags containing new socks, caps and gloves, plus small snacks for local homeless veterans.

Continuing on the theme of service to veterans, on December 15th we participated in Wreaths Across America at two local cemeteries, including the local Native American Cemetery on the Shivwits Band of Paiutes Reservation near St. George. The ceremony at Shivwits Cemetery began with a prayer offered in the Paiute language, and later in the ceremony, two songs

were sung in Paiute by a native singer. Family members of veterans buried in the cemetery expressed appreciation for Wreaths Across America; we were told it was the first time the Native American veterans had ever been recognized and honored by the community.

The theme was "The Boston Tea Party", and chapter members and guests were encouraged to attend in colonial costumes. Each guest was presented with a "Tea Party Timeline" created by Lu Fischer, and a commemorative package of Boston Harbor Tea manufactured by the same company that made the ill-fated tea dumped into the Boston Harbor: Davison Newman & Co Ltd of London. They are still in business! Additionally, each guest received a copy of the original petition by the tea company to "The King's most excellent Majesty" asking to be compensated for their lost cargo. The company was never compensated.
