This summer, elections for a new National Executive Board will take place at Continental Congress. Carole is a candidate for the Office of Organizing Secretary General with the Calvin Associates. She is currently National Chairman for the DAR Scholarship Committee.

Carole has served DAR well: Vice President General, Honorary Missouri State Regent, State Vice Regent, State Chaplain, State Registrar, various State Chairmanships, Elizabeth Benton Chapter Honorary Chapter Regent, Chapter Regent for four terms, and many Chapter offices and chairs.

Carole received a Bachelor of Arts Degree in Elementary Education from Drury University, and a Masters in Education from Fontbonne University. She is a former elementary school principal and teacher, financial planning advisor, Savings and Loan Training Director, and Human Resources Director. Her interests are varied: she is an author of children's books, member of Kansas City Needlepoint Guild, Board Member of Kansas City Historic Home Association, member of P.E.O. Sisterhood, and a Village Presbyterian Church member. She and her husband, John, live in Kansas City, Missouri.

After moving to Utah, Ellen organized Provo's Wasatch Range Chapter in 1974. She served as Utah State Regent, 1995-1998. In 1998, Ellen was elected as a Vice President General.

Ellen served in the Watkins Administration as the Recording Secretary General, National Chairman of the Investment Committee, and National Vice-Chairman of the Finance Committee. Currently, she serves as National Chairman of Printing and Publications.

Professionally, Ellen graduated from the Eastman School of Music, University of Rochester, in Horn performance and music education. She holds a Master's degree and a Doctorate in Educational Leadership and Foundations. Dr. Powley is well known as a speaker to education organizations throughout the U.S., and has been honored by the National Rural Education Association for research in the British Isles. She is an elected member of Phi Kappa Phi, and currently holds the position of Associate Lecturer in the Women's Research Institute at Brigham Young University.

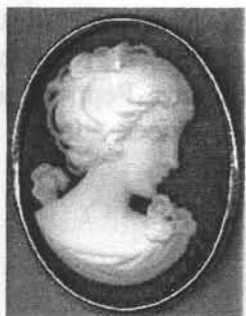
Conference Reports

Records Management Recommendations for DAR Chapters

Many questions have been asked about what to retain and where to store those records when the chapter does not need them on a regular basis. Below you will find a very brief outline on how to handle this problem. For the full report, please go to the National site at www.members.dar.org. Click on "forms," then on "Historian General." Scroll down and click on the Records Management section.

Records Retention:

Chapters are required to retain the following records on a permanent basis:

- Application papers
- Secretary's minutes
- Treasurer's reports
- Official correspondence- any correspondence created in the course of DAR business. Chapter Regents have the authority to decide what correspondence is "archival" and what can be weeded from the collection and not retained by the chapters or state society.

It is recommended that chapters permanently retain their charter as well as any yearbooks in their possession. All the above listed records should be considered permanent records of the chapter and retained as the chapter history. Other holdings, including scrapbooks, duplicates, early drafts of reports, photographs, even programs, etc., also may be kept if the members wish to do so.

Records Storage:

One option for storing chapter records is to rent a climate-controlled self-storage facility. This allows members to pass the key to the storage unit to their successor rather than shifting boxes from one officer's home to the next. Take care to store records at least four inches off the floor.

There is still space in the USSDAR storage unit for records not requiring frequent access. If you need help in arranging to store your records, contact me or our State Historian, Jolene Bushman.

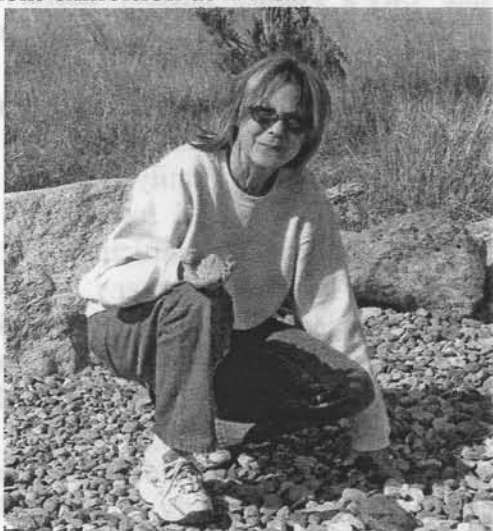


Bald Eagle Chapter

At a memorial service, seven new name bricks were laid. Harriet and associate member Jolene Dodge placed bricks for their loved veterans.

Winnie Washburn traveled to BYU in October to place "The Nun's Flag" in the BYU World War II exhibit. Winnie presented Dr. Freeman, exhibit creator, an award stating her appreciation for his work in history and his celebration of the history of "The Nun's Flag." The flag may be remaining on permanent exhibition at BYU.

Wasatch Range Chapter

On November 18, 2006, Wasatch Range Chapter honored Technical Sergeant Ralph Hall by presenting him with the World War II DAR medal.

Sergeant Hall was a member of the US Army, inducted into service on 7 May 1943. After receiving his training, he departed with the First B-29 group that flew into India.

The first B-29's to bomb Japan departed India in June 1944. Six months later, Sergeant Hall flew over the Himalayas to Chengtu, China. The Japanese bombed this Chinese base, and Sergeant Hall had several close calls while stationed there. After six months, he flew back to India. Several months later, he flew to China and on to Okinawa. On the way to Okinawa, he had to fly through a typhoon and over enemy territory.

Sergeant Hall's parents had four sons, and all served in the war. Ralph and Melvin were stationed on Okinawa at the same time. Lester, another brother who had been stationed in the South Pacific for three years, flew to Okinawa for a reunion with his brothers.

Utah Has Had Three ...

For years, there were rumors that Utah had a Vice President General a long time ago. However, there was no proof in state scrapbooks nor at National. Last summer, while going through old scrapbooks for Golden Spike, the documentation was discovered.

Mrs. Ralph E. Bristol (Florence Root-Day) was elected in April 1931, to complete the term of a deceased member.

Pictures of her attending a function in Ogden wearing the VPG sash and copies of the news article were sent to DAR Headquarters. After a search of documents in Washington, DC, DAR sent a letter to Donna Severson, Honorary State Regent, verifying that Utah did indeed have their first VPG many years ago.

Utah's second and third Vice Presidents General were Golden Spike Chapter's Martha Maughan and Ellen Lockwood Powley of Wasatch Range Chapter.

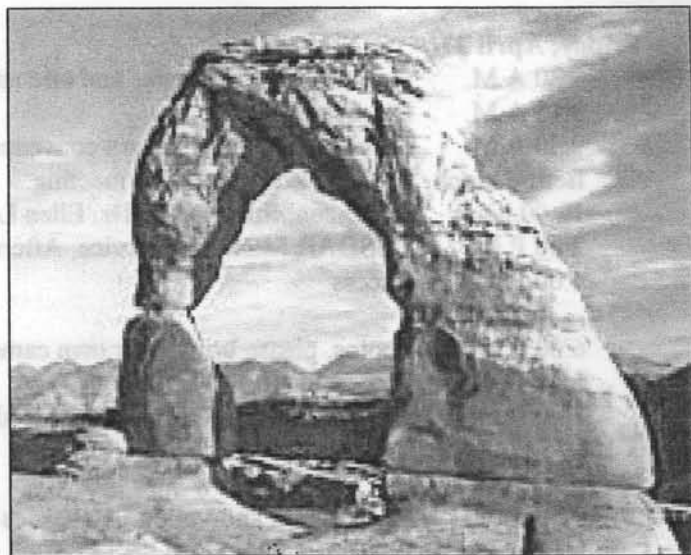
