I was proud to represent you, Utah Daughters, at Continental Congress in June. Utah was one of only four states to be recognized as achieving 100% participation in the President General's Project; Utah was also recognized as a Benefactor of the President General's Project thanks to your contributions to this project through the state regent's project. Golden Spike Chapter received a national first place award from the Commemorative Events Committee for Hollie Gilliland's program on Ellis Island; Colette Kingsley, of

Wasatch Range Chapter, was recognized as a first place winner in the fiber arts division of the American Heritage contest.

Utah Daughters epitomize the DAR motto of service to God, home, and country. Because you serve, students are able to shine. For the second year in a row, a Utah student was a national winner in a DAR contest. Jacie Child was blooming with pride as she received her American History Essay award at Continental Congress. Each award we give, whether at the chapter level, state level, or national level, is important to the recipient, their family, and their community.

Because you share your time and resources, veterans and active-duty military are not forgotten. You can still contribute to the state regent's project; the second stage of the project is to support the Valor House, a transitional housing project for homeless veterans. This October, each chapter is asked to engage in a service project on or about October 11, our official birthday, which is being called our "DAR Day of Service". If you cannot participate with your chapter, find a way to get involved. I look forward to hearing how you celebrate!

Golden Spike Chapter has become a Commemorative Partner with the Vietnam War Commemoration sponsored by the US Department of Defense. As part of that association, we honored eight Vietnam veterans at our Flag Day Observance held June 12<sup>th</sup> at the HAFB Aerospace Museum. Col. Patrick Burke, husband of member Shannon Burke, facilitated using the auditorium. The veterans, representing all military services, were recommended by chapter members. Our members and families and guests of the veterans were the audience. Following the Pledge of Allegiance, and "The Star Spangled Banner," NSDAR Vice President General Cindy Toone addressed the group, explaining DAR goals and activities, including support of the US military, and Flag Day. Sego Lily member Joan Yarrington and her HODAR Dennis performed two moving patriotic songs. Lt. Col. (Ret.) Leon C. Thurgood, who was among those honored, was a helicopter pilot in Vietnam three years, and then served several years at the Pentagon. He spoke of his experiences, the men he

met, his feelings for our nation and flag, and closed with a touching video tribute, "Taps."



Regent Lorilee Beazer read a short profile of each veteran, five of whom have received Purple Hearts. (Three more veterans, not able to attend, received their awards later.) ### FROM THE STATE REGISTRAR

Hello from your State Registrar. There have been a few changes made in order to help you. There is electronic filing, a new application and other changes coming. Y-DNA is also being used to confirm relationship.

State Registrars now have access to Pre-Letters, although we will not be able to see the application due to privacy restrictions. Pre-letters are code generated form letters; should you need help determining what the issue is, feel free to e-mail me. Would you believe that there are pre-letters for things such as incorrect signatures, missing endorsers, etc. that are more than a year old!

Handwritten names for Member 4 Member (M4M) credit have not been allowed since February 2012. Also, some National Numbers for M4M credit are mistyped, resulting in the wrong person being credited. Double check the National Number and type it on the application and check it again. The "Application Processing Analysis" reports covers 2013, 2014, and our current year of 2015. It shows problem applications and other things. The State Registrar, State Regent, State First Vice Regent, State Organizing Secretary, State CDRC Chairman, and State Chairs/Co-Chairs of Lineage Research and Volunteer Genealogists can review this report in order to help solve the problem. These suggestions are just a few things that made a difference to me when I joined DAR in 2008. Chapter Membership, Growth and Retention are the responsibility of all members of a Chapter, not just the Membership Chairman and the Chapter Registrar.

The goal of 10 million community service hours was met during Continental Congress in June. Twenty thousand more hours were recorded in addition to the goal. Utah had over 45, 000 hours! That is phenomenal! Please continue to log your hours to the online tally on the DAR member's website. A new goal has been set at 12.5 million hours in recognition of the 125<sup>th</sup> anniversary by the end of Continental Congress 2016.

### Cindy Toone, Celebrate 125! Chairman

On October 11, 1890 the National Society Daughters of the American Revolution was founded. On October 11, 2015 to commemorate the 125th anniversary of the DAR, The Utah State Society will place a wreath on the grave of Mrs. Elijah Sells at Mount Olivet Cemetery. Harriet Jacques Wetmore Sells (Mrs. Elijah Sells) is one of only 167 DAR members whose graves are marked as a Real Daughter. Mrs. Sells' father, Bela Wetmore, fought during the American Revolution. President General Lynn Young has encouraged chapters from coast to coast to complete special service projects for their local community on October 11, 2015. Ask your Chapter Regent about the National DAR Day of Service, and how your chapter will join the celebration.

At the Utah State Conference this year, a Celebrate 125 fund was started. A donation of 125 cents was suggested to celebrate 125 years of DAR history. Each chapter was provided a Celebrate 125 container and Commemoration Sheet. Each daughter that contributes should place their name on the Commemoration Sheet. ## 2015-2016: Title: "A Colonial Family's Reaction to the Stamp Act"

Topic: March 22, 2015 marks the 250<sup>th</sup> anniversary of the Stamp Act. Passed by the British Parliament in 1765, this new tax required all colonists to pay a tax on every printed piece of paper they used. The Stamp Act was viewed by the colonists as "taxation without representation." Describe a colonial family's discussion about the new Stamp Act and what role it played in organizing the colonists against the British King and Parliament.

For High School students, we have the Christopher Columbus essay contest. There are not as many that enter this one, so your students have a greater chance of winning, so encourage them to do so. The theme this year is very interesting:

## 2015-2016 Title: "Columbus and Lindbergh: A Journey Across the Atlantic"

Topic: Discuss the similarities and differences between Christopher Columbus' voyage to the new world and Charles Lindbergh's first solo flight across the Atlantic Ocean. What affect did the 400 years between their accomplishments have on what each man hoped to achieve, the challenges they faced, and the skills essential to their success? I hope each chapter can find at least a few students to write essays. And don't forget to honor Women in American History and write about all your "historical" programs on the MQ. I think we are under-reporting those. If it is about history, it is a historical program, even if it fits in to be reported under other categories.

We were so happy to see so many Utah Daughters at our Applications and Supplementals Workshop on May 30. If you weren't able to attend, you can still access the handouts by clicking on "Files" at the top of the USSDAR *Facebook* page; there are four files that you can download.

At the recent Continental Congress, Registrar General Sharon Withers confirmed what we've heard hinted at for a while: online submission of applications is coming, and it's coming this year! Not many details have yet been released, but there's no reason to panic at this point: it will be an "optional option" for the foreseeable future.

Online submission will help DAR in at least a couple

of ways: it will streamline in-processing of applications, which involves scanning the applications and supporting documents; and it will streamline the creation of the GRS databases because the data will have already been input before it gets to Washington, DC. For the rest of us: no more worrying about printing on "special paper," no postage, and no wondering whether the application made it to DAR in one piece. DAR is developing a webinar to teach us how to use the new system, and we will keep you posted Those of you who attended the workshop will remember that we spent some time on the writing of an "analysis." In the last couple of weeks, the grapevine tells us that the Genealogy Department is looking harder at analyses now, and are requiring that they be submitted using the exact format shown on the member's website (http://www.dar.org/members/applicationssupplementals/submitting-andapplication/acceptability-documentation). Also, they are paying particular attention to the "exhaustive search" section and want to see not only what you searched, but where. "Have Writtens" are being issued for failure to meet these requirements. If you are not sure an analysis you've written meets the requirements, I'll be happy to review it for you.
