



Our guest speaker, William Auger, a veteran and life-long volunteer with the American Legion, provided a very interesting historical speech, wherein he discussed the responsibilities required of previous President's wives or hostesses. He was awarded the National DAR Award for Excellence in Community Service with a certificate and pin. Refreshments, provided by the Preston daughters, followed the meeting.

Our June 2012 Picnic was honored with the presence of State Regent Cindy Toone, who helped us dedicate three new trees at the Mendon City Park. The Boy Scouts reverently conducted a flag burning ceremony for the disposal of old flags. Cindy Toone installed the Bear River Chapter Officers for 2012-2013. We then had a potluck salad luncheon at the home of Marilyn Swedin.

Our 2012-2013 yearly schedule will begin in September at an Inn in Preston, Idaho. Our new State Regent, Shirley Nelson, will honor us with a short summary of the DAR 2012 Continental Congress in Washington, D.C. We then will take a walking tour to the Oneida Stake Academy, where Necia Seamons, chairman of the Oneida Stake Academy Foundation, will give us an update on the continuing restoration of this venerable historic school, which was established in 1890 to serve the large farming and ranching community of southern Idaho. The Bear River Chapter is honored to have been the sponsor for a DAR National \$9,720 grant, which was given to the Oneida Stake Foundation, for the preservation of the Bell Tower. The restoration of the Bell Tower will provide a tangible beacon of the historic heritage of this building to the community. After the tour, we will return to the bed and breakfast inn for a catered luncheon.
