Proposed Amendments to Bylaws of USSDAR

The state bylaw committee proposes the following changes to the state bylaws. The State Society will vote on these proposed amendments during the State Conference in April. A vote of 2/3 of the delegates in attendance is necessary to amend the bylaws.

To amend ARTICLE VIII MEETINGS

Section 1. currently reads: The Annual State Conference of the Utah State Society shall be in March unless otherwise ordered by the State Society or the State Board of Management.

The Committee proposes amending Section 1 to read as follows:

Section 1. The Annual State Conference of the Utah State Society shall be in April unless otherwise ordered by the State Society or the State Board of Management.

Rationale: Housekeeping. The State Conference has been held in April for several years and this will bring our bylaws in line with what we have been doing.

The Committee proposes adding the following Section 2:

Section 2. The current State Regent is the only member authorized to sign contracts on behalf of the State Society. Due to the necessity of scheduling some statewide events more than a year in advance in order to secure appropriate accommodations, the current State Regent may make firm arrangements, as to date and meeting place for these events which may take place during the administration of her successors. If the State Regent is absent or unable to perform these duties the State Vice Regent is authorized to assume the responsibilities.

Rationale: The Office of the President General, NSDAR plans the visits of the President General at the beginning of her administration for the next three years. Our State Regent is asked to submit to them dates and hotel accommodations for her visit to our State Conference, even though it may be after the end of our current State Regent's term. This amendment clarifies the authority of the current State Regent to carry out these plans.

In January, we toured the Bountiful Food Pantry and learned about the service they provide to our community. In March we recognized our Good Citizen winner, Marsadies Wagstaff, from Clearfield High School. We are pleased to have installed several new members.

Our September speaker in 2013, was our State Regent, Shirley Nelson, who came and informed us about her "Points of Light" Project. We learned about "Celebrate America" and our volunteer hours we need to report. We celebrated Constitution Week with a display, and our Recording Secretary, Katie Madsen, invited the Mayor of Lehi, Bert Wilson, to display a proclamation declaring Sept 27-23 as Constitution Week.

Our own Kim Harrison received the Martha Washington Medal for securing a \$180,000 three-year renewable grant to fund the SAR's Operation Ancestor Search, a free program that teaches genealogical research to wounded warriors in military hospitals and medical centers across the country.

In October we learned about Sacajawea, heroine of the Lewis and Clark Expedition, presented by Katie Madsen. We collected items for Veterans Christmas

stockings and filled 25. We also began a book drive for the Welcome Baby Program of the United Way of Utah County.

Our November meeting was on Calvin S. Smith as a WWI Chaplain, presented by Helen Rabe, State Chairman of National Defense, and her two sisters who gave a short history of their father.

Our December meeting was Sounds of Christmas presented by Ron Roberts, piano soloist, (who is legally blind) and an Annual Cookie Exchange.

In January Arlene Andrus and her daughter Thalia Taylor reported on their trip to Russia and Glemboka to visit their ancestor's home, where they discovered family history which was lost for many years.

Our February meeting was President Abraham Lincoln, presented by Mark Bezzant. In March we were pleased to hear 5th, 6th, 7th, 8th grade students reading their winning essays on The Life of Children of the American Revolution. We had 55 applicants from two schools.

At our May meeting we will celebrate our Wasatch Range chapter's 40th Anniversary and 100th year of Mother's Day. Ellen Powley, Honorary State Regent, will give us our chapters' history.

Our Chapter reported 5,214 volunteer hours for 2013, and that is only from about one third of our members. Watch out for next year, we hope to more than double it.

This has been an eventful year. We had 4 new members and 1 junior member join our Chapter last year and have already had several more join this year.
