# State Conference Special Guests

## ***Janet C. McFarland, State Regent, District of Columbia***

Janet C. McFarland joined DAR as a Junior Member in 1988. She served her chapter and state in many offices including State Treasurer, State Vice Regent, and now State Regent. She is honored to lead the over eleven hundred District Daughters in eighteen chapters in Service to America. Her administration's scripture, "Serve one another with whatever gift each of you has received," embodies her desire for people to discover, develop, and give of themselves and their gifts for the betterment of our society and country.

Ms. McFarland also serves as the National Vice Chairman for Member Training for NSDAR's Membership Committee. In 2012, Ms. McFarland created a New Members Course for the District of Columbia State Society. This course was the model for the NSDAR New Members Course that is now being rolling out national by the Dillon Administration and as the National Vice Chairman for Member Training, she is responsible for the development and support of the New Members course and New Horizons leadership course nationally.

Stan Ellsworth is the Harley Davidson-riding host of *American Ride*, the Emmy Award-winning American history program seen on BYUtv. His family lineage includes Revolutionary War patriots Ethan Allen, Henry "Light Horse Harry" Lee, General Daniel Morgan, and General Robert E. Lee; American folk heroes Daniel Boone and Davy Crockett; the notorious Frank and Jesse James; and . . . General George Washington. Small wonder he went on to earn a bachelor's degree in history. He also played and coached college football at several universities, including the University of Utah. Among his many adventures, Stan taught high school students where he brought his knowledge and unique personality to the classroom, calling upon his love of liberty to bring American history to life.



With Stan you should always expect the unexpected. As the creator and host of *American Ride*, he seeks to bring truth to the retelling of our nation's history, and how Providence has played a big part in the founding and success of the American nation. *American Ride*, now shooting seasons 11 and 12, preserves and preaches that message for all. The show has become a weekly highlight for nearly 11 million Americans, and more overseas via the Internet.

Stan has appeared in 18 feature films and numerous television shows, and he narrated the *Bounty Hunters* documentary for the Discovery Channel, as well as *True Caribbean Pirates* for the History Channel.

For *American Ride*, Stan has received recognition from the American Academy of Television Arts with seven Emmys, including numerous Best Host awards. He has also been honored by the following: Sons of the American Revolution, with a Silver Medal of Citizenship; National Coalition of Motorcyclists, with the Silver Spoke Award; American Freedoms Foundation at Valley Forge, with the George Washington Gold Medal of Freedom; Boy Scouts of America, for Patriotism; the Honorable Gary Herbert, Governor of the State of Utah, for Service to the State; and several Sergeants Major of the United States Armed Forces, for Distinguished Service to the Nation.

Stan and his wife Stacey are the proud parents of six children and have seven grandchildren. They now make their home in the mountains of Northern Utah. We will be hearing from Stan Ellsworth during our Friday night banquet.

# Utah DAR Leadership Updates



## *State Registrar Report: Clearing the Air*

### Who Should Research New Applications?

A frequent topic of discussion is: who should do the research on Prospective Member (PM) applications? It's a controversial subject to be sure, with opinions ranging from the PM does it all to the Registrar does it all. A frequently-expressed opinion is that the PM should do all or most of her own research so she will have a vested interest in her membership. This discussion is important, not only for Registrars, but for chapters as a whole; and the answer will have much to do with whether chapters are successful in meeting their membership goals.

Here is my answer: if chapters wait for PMs to do all or most of their own research, chapters will have few new members. You may not like this answer, but it's true. DAR requires lineage research that adheres to today's accepted genealogical standards and very few of your PMs are competent genealogists. Look at your chapter's most valuable and active members: how many of them are competent genealogists? Why pass up great members who will be assets to your chapter just because their interests and talents lie elsewhere?

A good rule of thumb might be: rely on the PM to provide the documentation for her first three or four generations and we do the rest, as necessary; depending on the age of the PM, it will be difficult for us to document those recent generations.

So, what to do? Make the chapter Registrar turn her office into a full-time job, researching multiple applications at once? That is a great way to cause "Registrar burn-out" and make the job look so difficult that no one will want to do it. Many of us have "been there/done that" and it's not a good way to go.

These issues need to be considered by chapter management carefully and not left to the Registrar to deal with on her own. Consider a three-pronged team approach; you need –

- A membership function to handle all aspects of PMs, except for the application itself: keeping in contact with PMs until they are ready to start their applications; inviting them to all meetings and events; meeting, greeting, and encouraging; providing PM packets; and maintaining the Prospective Member Database (PMD).

- A lineage Research function. Ideally every chapter should have a Lineage Research *Committee* (which means not just a Chair) to work with the PMs on their applications, gathering documentation, and deciding what is needed. This committee could consist of all or most of a chapter's genealogically-inclined members. Most of these might not be interested in serving as Registrar, but would be happy to work with one PM at a time on her application. Divide and conquer!

- The Registrar, who controls the application process: meeting with the PM to determine whether she has a Patriot in mind, her genealogical expertise (if any), and what research has already been done (if any); letting the chapter Lineage Research Chair know when a PM is ready to get going and what the issues might be; reviewing complete or nearly-complete lineages for adherence to genealogical standards; preparation of the application from documents supplied by the PM or the Lineage Research Committee; coordination of signatures, payment, submission, and monitoring the status of the application once it reaches National; maintaining the PMD; and of course, researching where time allows.

How is your chapter handling these functions?

- The course consists of various modules/topics which help the new member explore the different aspects of DAR, i.e. DAR Protocol; DAR Schools, etc. via a DAR Webinar or YOUTUBE video.
- Each topic has a writable questionnaire form which must be completed.
- Also, attendance at the August State Workshop as well as State Conference is strongly encouraged.
- A member has one year to complete the course work along with the Independent Project.
- The course is designed for members to work at their own pace.
- A graduation ceremony will be held at State Conference in April.
- The cost is \$10 and checks should be made payable to USSDAR.
- The New Members State Coordinator administers the course.
- The New Members Course is not a pre-requisite for the New Horizons Course.
