Tammy Bradshaw Clemmons, Alabama State Regent



Tammy Bradshaw Clemmons joined the National Society Daughters of the American Revolution in 2007. She was installed as State Regent of the Alabama Society DAR in June of 2018 during the 127th NSDAR Continental Congress in Washington, D.C. Her three-year term as leader of 69 Alabama chapters with over 4,300 members will last until June of 2021.

Tammy currently serves the National Society as Vice Chair, DAR Schools Tour. Her previous national service includes being the President General's Advisor to the KDS DAR School Board of Trustees and Vice Chair for the Registration Line at Continental Congress, both in 2013-2016.

Prior to being elected Alabama State Regent, Tammy held the office of First Vice Regent from 2015-2018 and held state chairmanships for the Membership

Committee and the DAR School Committee. She served as regent of the Gunter Mountain Chapter, NSDAR, from 2011-2013.

Tammy is a 1981 graduate of Kate Duncan Smith DAR School in Grant, Alabama, one of only two DAR Schools in the country. She graduated from Austin Peay State University in 1987 with a Bachelor's of Science in Medical Technology. Tammy has been a registered Medical Technologist for 31 years, 26 of those years in the Blood Bank Department at Huntsville Hospital located in Huntsville, AL, where she is currently the Lead Blood Bank Technologist at the 941 bed facility.

Tammy and her husband David, an award winning amateur rose hybridizer, grow more than 250 exhibition roses in their rose garden and exhibit them on the local, state, and national level. In honor of their 20th wedding anniversary, David named his newest award winning rose "Tammy Clemmons".

Tammy has one son, Chris, a 2008 graduate of Kate Duncan Smith DAR School and a 2013 graduate of Auburn University.

Sharon Kay Mayne Withers, Nat'l Chair DNA Network Committee

Sharon Mayne Withers is a native of Whitley County, Kentucky, the seventh generation to be reared on the family farm located on the waters of Poplar Creek in the mountains of Eastern Kentucky. Her lifelong love of genealogy was nurtured by her beloved maternal grandmother. Sharon transcribed her first cemetery at the age of eight and wrote her first genealogical article for publication at the age of 12. Her special interests of late have been researching the Cornish roots of the Mayne family and the use of DNA as a tool for finding those elusive ancestors.

Sharon has been heavily involved in the Daughters of the American Revolution since joining in 1985. She was Kentucky State Outstanding Junior Member in 1990. She served the Kentucky Society as Vice Regent, Organizing Secretary and District Director before becoming State Regent from 2007-2010. She has served the National Society as Registrar General, 2013-2016, Vice President General, 2010-2013, and as National Chairman, Junior American Citizens. She currently serves as the National Chair of the DNA Network Committee and is a member of the Hindman Settlement School Advisory Board.

It was a thrill of a lifetime to present a lecture on DNA to a packed auditorium on the Celebrating American cruise. Afterwards, then President General Lynn Young was on an elevator with a man who asked her if she was with DAR. When she replied in the affirmative, he said "You need to get that woman who gave the DNA lecture in DAR."

Sharon has a BS in Medical Technology, MS in Hematology and Clinical Education and is a Master Technologist, Special Hematology, University of Kentucky Hospital. She is a member of 25 lineage societies and is currently the Registrar General of two and the State Registrar of two. She is the author of two books of transcribed records. Sharon and her husband Dennis have been married 40 years and have two daughters and four granddaughters---and all their family pets have been female!

Denise Bennett, Saturday Breakfast

Denise Bennett is a lifelong volunteer. Mrs. Bennett is a 1st and 2nd generation American whose husband can trace his

ancestry back to several of the Pilgrims who came to America in 1620 on the Mayflower. She has researched her genealogy for over 20 years, going on numerous research and ancestral journeys including to Ireland and Scotland. Despite her very recent immigrants, she can trace her lineage in America back to the



American Revolution and to the second ship that arrived in Plymouth, Massachusetts in the 1620's. She joined the Daughters of the American Revolution in 2013 with one of the most international applications. In her first 3 generations she had proof documents which required translations in 3 different languages - German, Spanish and old Persian. Denise was one of 41 graduates in the first graduating class of the TX State New Horizons Leadership Training course in 2017. She is a proud organizing member (registrar) of the Twin Creeks Chapter, NSDAR and currently serves as Vice Regent. Denise also serves as one of four TX State Vice Coordinators of the New Horizons course, assisting TX students through the course. Denise also serves as the TX State Vice Chair for Commemorative Events with a focus on Womans Suffrage. As a 1st and 2nd generation American, Denise has always felt voting is an important civic duty.

Jay Buckley, Friday Banquet

Jay H. Buckley (PhD, Nebraska) grew up in Bridger Valley, Wyoming. Buckley is an Associate Professor of History at Brigham Young University where he teaches United States, American West, and American Indian history courses. Buckley directs the American Indian Studies minor and is the director of the Charles Redd Center for Western Studies.

Buckley is the author of the award-winning book, William Clark: Indian Diplomat (2008). He is co author of By His Own Hand?: The Mysterious Death of Meriwether Lewis (2006); Orem [Utah] (2010); Zebulon Pike, Thomas Jefferson, and the Opening of the American West (2012); Historical Dictionary of the American Frontier (2015); Explorers of the American West: Mapping the World through Primary Documents (2016); and, Explorers of the American East: Mapping the World through Primary Documents (2018). Current book projects include: Great Plains Forts (Center for Great Plains Studies/University

of Nebraska Press) and A Fur Trade History of the Great Plains and Canadian Prairies.

Professor Buckley directs college-credit field studies every summer for the Driven2Teach Program (www.driven2teach.org), which gives Utah educators, grades 5-12, who specialize in American History, a hands-on learning experience at historical sites around the country. He and his wife Becky are the parents of three children.



Katharine Coles, Saturday Student Awards Luncheon

Poet, novelist, and editor Katharine Coles earned a BA at the University of Washington, an MA at the University of Houston, and a PhD at the University of Utah.

Coles is the author of several collections of poetry, including *Fault* (2008), Utah Book Award winner *The Golden Years of the Fourth Dimension* (2001), and *The One Right Touch* (1992). She is also the author of the novels *Fire Season* (2005) and *The Measurable World* (1995). Her collaboration with visual artist Maureen O'Hara has led to the artists' book *Swoon* (2003) as well as several installations. As the inaugural director of the Harriet Monroe Poetry Institute, Coles edited the anthology *Blueprints: Bringing Poetry into Communities* (2011) and the reports *Poetry & New Media: A Users' Guide* and *Code of Best Practices in Fair Use for Poetry*. Her fifth poetry collection, *The Earth Is Not Flat* (Red Hen 2013), was written under the auspi-



ces of the U.S. National Science Foundation's Antarctic Artists and Writers Program. Her chapter book, *Bewilder*, was published in the fall of 2015 by the International Poetry Studies Institute at the University of Canberra, and her sixth collection, *Flight*, from Red Hen was published in 2016. She is also the co-PI on the Poemage project, which develops software for analyzing and visualizing sonic relationships in poetry; she has written a number of scholarly articles and presentations based on this work.

Coles has received numerous honors for her work, including a term as Utah's poet laureate (2006 to 2012), both a fellowship and a New Forms Project grant from the National Endowment for the Arts, a PEN New Writer's Award, an Antarctic Artists and Writers Grant from the National Science Foundation, and grants from the Utah Arts Council and the Salt Lake City Arts Council.

At the University of Utah, Coles has directed the Creative Writing Program; co-directed the Utah Symposium in Science and Literature, with mathematician and biologist Fred Alder; and served as series editor for the University of Utah Press's Agha Shahid Ali Poetry Book Award. She lives in Salt Lake City.

Katherine Kitterman, Friday Luncheon

Katherine Kitterman is the Historical Director for Better Days 2020, a non-profit dedicated to popularizing Utah women's history through education, legislation, and art. She has extensive research experience in American women's history, as well as public history training in historical interpretation and public programming.

Katherine earned her B.A. in International Relations and German Studies from Brigham Young University, and also earned a Master of Public Policy degree at BYU. She is currently a Ph.D. candidate in American History at American University in Washington, D.C., where she has worked to bring history to

life at the Smithsonian Institution, the Holocaust Memorial Museum, and the Woodrow Wilson House. Katherine's dissertation analyzes the rhetoric of Utah women's struggle for suffrage in the nineteenth-century, highlighting the two-way connection between suffragists in West and East.

Introduction to "The Womans Hour" Denise Bennett, Saturday Breakfast Speaker

Carrie Chapman Catt was one of the best-known women in the United States in the first half of the twentieth century and was on all lists of famous American women. As President of the National American Womans Suffrage Association and the International Womans Suffrage Alliance, she led an army of voteless women in 1919 to pressure Congress to pass the constitutional amendment giving them the right to vote and convinced state legislatures to ratify it in 1920.

The struggle for women suffrage was a long bitter fight. It was waged on street corners and atop soapboxes, in city halls, Grange Halls, and the halls of Congress; it was fought in parlors and kitchens and bedrooms, under statehouse domes, at the bench of the US Supreme Court, and finally in the Capitol Bldg in Nashville and the elegant lobby of the nearby Hotel Hermitage.

Tennessee proved to be the last hope for suffragists. Situated between pro-suffrage states to its north and west and anti-suffrage states to the south and east, Tennessee proved a

pivotal border state in the struggle to secure ratification. Indeed, the last battle to be fought in the campaign for national woman suffrage proved to be a fierce engagement as "suffs" and "antis" (as they were sometimes called) converged on Nashville in the blazing summer of 1920 to do battle. The TN Legislature would soon be called into special session to vote on ratifying the 19th Amendment to the US Constitution called the "Susan B. Anthony Amendment", one simple sentence stating that a citizen's right to vote could not be denied on account of sex.

Tennessee could become the 36th state to ratify. Or if they deny it, the amendment will be dead.

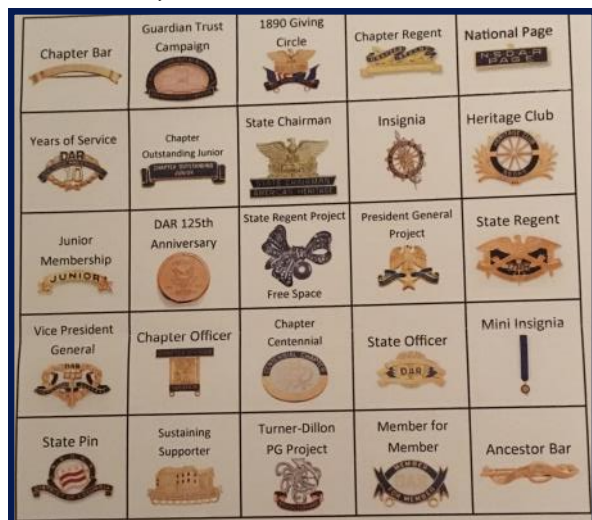

Proposed Amendments

BYLAWS OF THE UTAH STATE SOCIETY, NSDAR

January 12, 2019, Note – Underlined language is added. Language ~~crossed-out~~ is deleted.

Proposed amendment to ARTICLE VI

ARTICLE VI ELECTION OF OFFICERS

Section 6. (as amended 4/21/18) A member holding two or more offices carrying a vote may have only one vote at the Annual State Conference.

Amend by adding, State Board of Management meetings or meetings of the State Executive Board.

Text of amended Article

Section 6. A member holding two or more offices carrying a vote may have only one vote at the Annual State Conference, State Board of Management meetings or meetings of the State Executive Board.

Proposed amendment to ARTICLE VII

ARTICLE VII DUTIES OF OFFICERS

Section 1.

New sub-section. a. The State Regent may choose a project or projects to support during her administration and may raise funds to support said project or projects. Any funds raised for the State Regent's Project for that term which are not used by the end of December of the calendar year in which the term ends will roll over into the general fund of the State Society.

Rationale: Portions of this amendment were a recommendation by the Finance Committee in 2014. It was approved by the Board of Management but not adopted as an amendment to the bylaws.

Proposed amendment to ARTICLE IX DUES/FINANCE COMMITTEE

Section 5. All Chapter financial allotments to National projects, such as schools, the library, etc., shall be sent to the State Treasurer by each Chapter Treasurer no later than ~~January 10~~ with instructions for allocations and transmitted by the State Treasurer to the Treasurer General in the name of the contributing Chapter.

Text of amended Article

Section 5. All Chapter financial allotments to National projects, such as Chapter Achievement Award donations, schools, the library, etc., shall be sent to the State Treasurer no later than December one (1) with instructions for allocations and transmitted by the State Treasurer to the Treasurer General in the name of the contributing Chapter.

Rationale: To meet the deadline set by the National Society. The chapter calendar in the Treasurer General's Handbook states "December 1 or before Send Chapter Achievement Donations as early as possible to allow time for processing and recording." Funds need to be sent to Washington by December 15th in order to be properly credited for the current year and for Chapter Achievement credit.

Proposed amendment to ARTICLE XI

ARTICLE XI CHAPTER REPORTS/STATE REPORTS

Section 1. The Regents of each chapter in the State Society shall ~~send~~ submit to the State Regent annually on/or before the Annual State Conference a written report of the work of her chapter for the year. She shall also give a copy to the State Recording Secretary and the State Historian.

Text of amended Article

Section 1. The Regents of each chapter in the State Society shall submit to the State Regent annually on/or before the Annual State Conference a written report of the work of her chapter for the year. She shall also submit the report to the State Recording Secretary and the State Historian.

Rationale: To clarify the way annual reports of chapter Regents are given to the State Regent.

Section 2. create new Section 2. Each chairman of a State Committee shall submit to the State Regent annually on/or before the Annual State Conference a written report of the work of her committee for the year. She shall also submit the report to the State Recording Secretary and the State Historian.

Text of amended Article

Section 2. Each chairman of a State Committee shall submit to the State Regent annually on/or before the Annual State Conference a written report of the work of her committee for the year. She shall also submit the report to the State Recording Secretary and the State Historian.

Rationale: This has been the practice for many years, but not written into our bylaws.

Renumber remaining Sections of ARTICLE XI

Section 3. (previously Section 2). ~~Each chapter shall furnish a copy of its bylaws to the State Regent, who shall turn them over to her successor at the close of her term.~~

Text of amended Article

Section 3. A chapter regent must have on file with the State Parliamentarian, a current copy of the bylaws of her chapter, including any subsequent amendments.

Rationale: The proposed wording is taken from the current Chapter Regents Manual on the Organizing Secretary General's page of the DAR website.

Section 4. (previously Section 3). Each outgoing State Chairman shall deliver to the incoming ~~State Chairman or the State Regent~~ State Corresponding Secretary all books, papers and other materials, and memorabilia pertaining to her committee ~~before the Summer Workshop at State Conference the final year of her term as chairman.~~ at State Conference the final year of her term as chairman. The State Corresponding Secretary will oversee this process to see that it is done efficiently.

Text of amended Article

Section 4. Each outgoing State Chairman shall deliver to the incoming State Corresponding Secretary all books, papers and other materials, and memorabilia pertaining to her committee at State Conference the final year of her term as chairman. The State Corresponding Secretary will oversee this process to see that it is done efficiently.

Rationale: The amended article supports the duties of the State Corresponding Secretary as stated in Article VII Duties of Officers, Section 7.
